This includes the Installation, Commissioning, Testing, Maintenance & up keep of the complete link. The connectivity will be through dedicated Internet service. The vendor will provide the complete hardware required for the establishment of fully functional leased line.
- The vendor should have a valid ISP/ Unified Access Service License (UASL) license.

- The Vendor should have own access network or peering for providing last mile connectivity (local loop).

- The Vendor should have PoP level redundancy in major locations to ensure high availability.
- 11. The Vendor shall have Core Network built on Multi-tiered Hierarchy.
- 12. ISP will remain bound to provide services for at least one year to the. D.L.C State University of Performing & Visual Arts, Rohtak. If ISP fails to provide 100MBPS lease line services, all amounts will be refunded to the University.
- 13. The leased line must be operational 24x7. If due to any reason except force majeure, the services remained disruptive for more than 4 hours a penalty of ten times the proportional rental rate would be deducted from quarterly bill.
- 14. All the documents submitted by the vendors should be duly signed with seal. Submitting documental proof/Undertaking for fulfilling each condition mentioned above is sole responsibility of the vendor. In case proper document is not submitted, then it will be assumed that vendor doesn't fulfil that particular condition.
