- b) The candidate must read the HSTES B.Tech/B.Arch. Prospectus 2024-25 carefully.  
The candidates are required to report in the University offline, with full 1<sup>st</sup> semester fee (B.Arch.)
- c) The offline admission process will be completed only after payment of 1<sup>st</sup> semester admission fee in full after due verification of documents.
- d) The candidates shall not be allowed to participate in offline counseling without submission of required documents and the payment of 1<sup>st</sup> semester admission fee in full.
- e) The provisionally admitted candidates, at the time of reporting in the institute must

bring the following Original Certificates/ Documents/ Testimonials. Any candidate, who fails to produce any of the required Certificate/ Documents/ Testimonial at the time of reporting the institute, will forfeit his/ her claim to admission as per HSTES B.Tech/B.Arch. Prospectus 2024-25 without fail and Annexures present within prospectus in HSTES B.Tech/B.Arch. Prospectus 2024-25 is mentioned below: -

2. Qualifying Examination i.e. 10+2/Intermediate/ Senior Secondary School Examination.

5. Character Certificate:
  - a. Regular Candidates: The candidates who passed their qualifying exam. From School/ College as regular students are required to submit the Character Certificate as per Annexure-I.
  - b. Private Candidates: Candidates, who have passed the qualifying examination as private candidates should submit their Character Certificate, duly signed by a First Class Magistrate.
6. Residents Certificate, if applicable: Candidates, who have passed their qualifying examination from a Board/ Recognized School located in the State of Haryana will be deemed to be Haryana residents and will not be required to submit certificates of bonafide residents of Haryana.
7. Certificate from the Employer in the case of Employees of Govt. of Haryana, members of All India Services born on Haryana Cadre, Employees of Statutory Bodies/ Corporations as per Annexure-II, if applicable.
8. Scheduled Caste Certificate should be verified from PPP Data base, if applicable.
9. Deprived Scheduled Caste Certificate should be verified from PPP Data base, if applicable
10. Backward Class Certificate should be verified from PPP Data base, if applicable and income certificate should be verified from PPP Data base.
11. Economically Weaker Section (EWS) income and asset certificate as per Annexure-XI.
12. Certificate in respect of Divyang Candidates should be verified from PPP Data base as per Annexure-III, if applicable. \*The handicap disability should not be less than 40% and should not interfere with the requirement of professional career such as Pharmacy/Engineering/Architecture/Technician etc.
13. Certificate required to be furnished by the Children & Grand – children of Freedom Fighters as per Annexure-IV, if applicable.
